Decomposing Gender Wage Gap

Abstract

We analyzed the gender wage gap in Hellas (Greece) based on the European Structure of Earnings Survey for the year 2006. Within an extended human capital framework, we estimated augmented Mincerian models, using for the first time to this dataset, as far as we know, quantile regression econometric techniques. We found empirical evidence for individual, workplace and employer characteristics, as determinants of the hourly wage rate, for both males and females. We used the Oaxaca–Blinder (1973) methodology for the gender's wage gap decomposition which could be attributed mainly to unexplained part, and much lesser to the employee's endowment. This main finding was also verified for each one of the wage distribution's quantiles. Further research is needed for intertemporal and international comparison reasons.
